Seminar Content

Movement Pattern Analysis (MPA), created by Warren Lamb and Rudolf Laban, uses the observation of human movement patterns to assess an individual's motivation and unique decision making style.

By arrangement prior to and/or during the seminar itself, each participant has his/her own Movement Pattern Analysis profile by the instructor during a 1½ - 2 hour face-to-face interview. Interviews will be scheduled for August 24 or 25.

During the seminar, participants learn to recognize significant nonverbal behaviors through personal movement experience and observation practice and to understand how these behaviors relate to the decision-making process.

Topics covered include:

- 1) Discerning Posture-Gesture Mergers and their motivational significance
- 2) Identifying stages in decision making and their movement correlations
- 3) Understanding nonverbal cues that invite or preclude interaction
- 4) Learning how these factors combine to reveal an individual's “profile in action.”

By the end of the seminar, each participant is able to interpret a profile chart and comprehend his or her own characteristic process of making decisions. In addition, MPA profiles are used to create a hypothetical team. Students are introduced to concepts of team balance and how MPA can be applied to improve collaboration.

After the seminar, participants derive lasting value from knowing their own MPA profiles and understanding how movement patterns reveal motivation and decision-making processes. This seminar serves as a prerequisite for advanced training, and a number of students have gone on to become fully qualified as professional MPA consultants.

Instructor

Carol-Lynne Moore, Ph.D, CMA, worked closely with Warren Lamb for over 35 years. In addition to consulting work, she has taken a lead in training the next generation of Movement Pattern Analysts. Of late, she has been involved in applying MPA to study military and political leaders through research projects funded by the U.S. Department of Defense. Her publications on MPA and movement analysis include *Executives in Action, Movement and Making Decisions, Meaning in Motion: Introducing Laban Movement Analysis*, and *Beyond Words: Movement Observation and Analysis*.

Practical Details – Transportation, Venue, and Accommodations

Participants coming from out-of-state should fly into Denver International Airport.

Golden is 36 miles west of the Denver airport, on the western periphery of the greater Denver area. Direct driving time from the airport to Golden is 45 – 60 minutes. Shuttle service is available through SuperShuttle, www.supershuttle.com, and Golden West Airport Shuttle, www.goldenwestairportshuttle.com.

The seminar is being held in the meeting room of the The Dove Inn (www.doveinn.com), a charming Victorian bed and breakfast. The Inn is centrally located in the heart of Golden, within easy walking distance of restaurants, shopping, and other amenities.

Rooms are being held for seminar participants at the Dove Inn for the dates of March 16 - 19. To reserve a room, seminar participants must phone the Inn directly at 303-278-2209 and indicate that they are with the Movement Pattern Analysis group.

The seminar sessions will be held in the Dove Inn's meeting room. Individual interviews will be held by arrangement, either at the Inn or at the nearby home offices of MoveScape Center, with transportation provided.
